Such DSUs are fully vested at grant and are settled in cash upon retirement of the director based on the price of Enbridge Common Shares. The DSUs have no expiration date.
2. Includes 7 DSUs acquired by the Reporting Person between March 23, 2019 and June 14, 2019 pursuant to a dividend reinvestment feature under the Enbridge Inc. Directors' Compensation Plan.
